The ISO's responsibilities as Regional Transmission Organization include Transmission Cost Allocation (TCA). That means deciding who pays for regulated (not merchant) transmission projects, in a collaborative and transparent process, as follows: Transmission owners (TOs) submit a TCA application for projects that qualify for regional rate recovery.

Transmission Cost Allocation - ISO New England

The Transmission Enhancement charge compensates the transmission owners responsible for developing these projects. The costs of these projects are allocated across the zones based on a net benefit analysis by PJM. These charges can result in a credit if the transmission owner includes these costs in their NITS rates such as with PSEG.
