APA format is the official style of the American Psychological Association (APA) and is commonly used to cite sources in psychology, education, and the social sciences. The APA style originated in a 1929 article published in Psychological Bulletin that laid out the basic guidelines.

APA has a few formatting guidelines for the reference list. The reference list should start on a separate page at the end of your paper. Use one-inch margins and continue the header from the rest of your paper. Title the page References, centered at the top (no bold, italics, quotation marks, etc.).

APA reference page example In-text citations and references APA format citations consist of parenthetical citation in the text (in-text citations) and the full reference in the reference list. For each webpage, journal article, book or any other source specific citation guidelines apply.

APA Format for Academic Papers and Essays [Template]

APA in-text citation style uses the author's last name and the year of publication, for example: (Field, 2005). For direct quotations, include the page number as well, for example: (Field, 2005, p. 14). For sources such as websites and e-books that have no page numbers, use a paragraph number, for example: (Field, 2005, para. 1).

Formatting Your Paper - APA Citation Style Guide ...

The APA in-text reference is in the format (author, date). When directly quoting from a text you must include a page number in the citation as given in the examples below. Including page numbers in all other circumstances is not required however, it is best practice to do so when referring to part of a work (e.g. a paragraph or chapter in a book).
