Bidding: Delta - A system based on weak opening bids.
Bidding: Delta Asking Bid-A control asking structure associated with "Big Club" (Precision) and similar systems.
The convention, typically used in a game forcing auction after the Big Club opener makes a jump bid response (bypassing other possible asking bids by responder), asks responder to cuebid Aces up the line.

Discover the new bidding systems available on Funbridge Unusual bidding conventions must be “ alerted, ” which means that if you make an unusual bid, your partner must say “ alert ” or pull the blue “ Alert ” card out of the bidding box. The first opponent to bid may then (or at the end of the auction – their choice) ask the player alerting his//her partner ’ s bid what it means.

Guide to Bridge Bidding Conventions

With only 15 words allowed during an auction and just 13 cards in each suit, bridge players have invented dozens of special bids, called conventions, to describe their strength and hand patterns. These descriptions are from the ACBL Bridge Bulletin series called the Bidding Toolkit. The ACBL textbooks Commonly Used Conventions and More Commonly Used Conventions contain detailed chapters on the use of many of today ’ s popular treatments.

All of these older systems were built around a strong one club opening and four card majors, although the Europeans tended to favor a canapé style of bidding, where their second bid suit was longer than the first one. Strong club systems were never a popular choice, though, in either Europe or the United States.

The Precision Bidding System

A bidding system in contract bridge is the set of agreements and understandings assigned to calls and sequences of calls used by a partnership, and includes a full description of the meaning of each treatment and convention. The purpose of bidding is for each partnership to ascertain which contract, whether made or defeated and whether bid by them or by their opponents, would give the partnership their best scoring result. Each bidding system ascribes a meaning to every possible call by each mem

Bidding systems and conventions A pair is allowed to try to pass information about their hands, but this is restricted in two ways: Information may only be passed by the calls made and later by the cards played, and not by any other means. All information passed must be available to the opponents.
