Japan Chemical The Amended Japan CSCL issued by Ministry of Economy, Trade and Industry; Ministry of Health, Labour and Welfare, Ministry of the Environment entered into force in two steps on 1 April 2009 and 1 April 2011. The Toxic Chemical Substances Control Act (hereinafter referred to as "TCSCA") is the most important chemical control law in Taiwan with a goal of preventing toxic chemical substances from polluting the environment and endangering human health. It has undergone 6 amendments since its first promulgation on November 26, 1986.

The Korean Toxic Chemicals Control Act (TCCA) was implemented in 1991 by the Ministry of Environment (MOE) for the overall management and control of industrial chemicals in Korea. The latest revised version (Act No.895) took effect on 21 Mar 2008. The purpose of this Act is to prevent any risk caused by chemicals to human health.

The Act on Registration and Evaluation, etc. of Chemical Substances was promulgated by the Ministry of Environment of Korea (MoE) and came into force on 1 Jan 2015. The Act is well-known as K-REACH due to its similarity to the EU REACH regulation.

## *K-REACH*

The Japan Chemical Substances Control Law (CSCL) was firstly enacted on 16 October 1973 to prevent environmental pollution and control chemical risks to human health. The Law is intended to manage risks of industrial chemicals manufactured and imported in Japan. The 4th amendment of CSCL was published in June 2017 and took effect in April 2018.
