For the first time, 119 fragrance chemicals for commercial and consumer cleaning products have been added to the list. “Fragrances are an important yet complex part of many consumer cleaning products.

Non-fragrance materials (e.g., solvents) present in fragrance formulations will be evaluated under their appropriate Safer Choice functional class criteria. The Agency’s goal is to implement more sophisticated fragrances criteria, like the Safer Choice Criteria for Fragrances v2.1, in the future.

All components of a fragrance product must be included on the Fragrance Ingredient List (FIL) to be eligible to participate in the 2-year Pilot Fragrance Notification Program. Registrants can self-certify that all components in the fragrance are included on the FIL if the contents have been provided to them by the fragrance manufacturer.

Considering most of the fragrance ingredients on the Safer Chemicals List have been flagged as an area for safer chemical innovation, with only a few green circles, indicates that fragrance is inherently hazardous. Is EPA’s New Labeling Program Really a Safer Choice?

An inert ingredient generally is any substance (or group of similar substances) other than an active ingredient that is intentionally included in a pesticide product. Examples of inert ingredients include emulsifiers, solvents, carriers, aerosol propellants, fragrances and dyes.

We know only that styrene might be an ingredient in any given fragrance because the International Fragrance Association, an industry trade group, publishes an online “Transparency List” of ingredients that perfumers say they use in formulas for consumer products. Styrene is one of the 3,000-odd ingredients on the list.

For nonfood use fragrance formulations each fragrance component must have approval as a food use inert ingredient, a nonfood use inert ingredient, and/or be on the Fragrance Ingredient List (FIL). 28. One commenter noted that a few inert ingredients proposed for removal from the chemical substance list appear on the EPA Fragrance Ingredient List (FIL). The EPA FIL comprises more than 1,500 fragrance component ingredients that have undergone Agency evaluation to determine their suitability for safe use as components of fragrances in nonfood-use pesticide product formulations in accordance with the Fragrance Notification Program.

Federal Register :: Removal of Certain Inert Ingredients ...

Fragrance is a proprietary mixture of aroma chemicals, natural essential oils, and/or other functional components, the purpose of which is to impart an odor or scent, or to counteract a malodor. All Fragrance must comply with the International Fragrance Association Standards established by the IFRA Code of Practice (www.ifraorg.org).
