A Member FI will need to obtain its FATCA ID from its Lead FI . The FATCA ID is used to identify the Member FI for purposes of registration and is not the same number as the GIIN . A GIIN is issued to FIs, other than Limited FFIs or Limited Branches, after the FATCA Registration is submitted and approved .
