Used Car Rule. The Used Car Rule, formally known as the Used Motor Vehicle Trade Regulation Rule, has been in effect since 1985. It requires car dealers to display a window sticker, known as a Buyers Guide, on the used cars they offer for sale. The Buyers Guide discloses whether the dealer offers a warranty and, if so, its terms and conditions, including the duration of the coverage, the percentage of total repair costs the dealer will pay, and which vehicle systems the warranty covers.

The Federal Trade Commission Buyers Guide Rule is part of a Federal Disclosure law that requires all used car dealers to disclose warranty information in writing before the sale of any vehicle.

Enforced by the Federal Trade Commission, the Used Motor Vehicle Trade Regulation Rule - most people call it the Used Car Rule - requires dealers to display on used cars a window sticker called a Buyers Guide that contains warranty and other information. The Used Car Rule has been in place since 1985.
