Health Canada's role in bringing novel foods to market. Health Canada assesses the safety of all novel foods proposed for sale or advertising in Canada. Manufacturers are required to submit detailed scientific data for review by Health Canada before such foods can be authorized for sale. A team of Health Canada scientists carries out the assessment.

The mechanism by which Health Canada controls the sale of novel foods in Canada is the mandatory pre-market notification requirement as set out in Division 28 of

Part B of the Food and Drug Regulations (see Figure 1). Manufacturers or importers are required under these regulations to submit information to Health Canada regarding the product in question so that a determination can be made with respect to the product's safety prior to sale.

The regulations prohibit the advertisement or sale of a novel food before a notification is made to Health Canada by a petitioner. As part of the pre-market notification, you, as the petitioner, must provide information about the novel food so Health Canada can conduct a pre-market safety assessment of the product.

Novel foods are non-traditional foods that require assessment by FSANZ in order to establish their safety before they are added to the food supply. In Australia and New Zealand, novel foods and novel food ingredients are regulated under Standard 1.5.1 – Novel Foods in the Food Standards Code.

Novel Food is defined as food that had not been consumed to a significant degree by humans in the EU before 15 May 1997, when the first Regulation on novel food came into force. 'Novel Food' can be newly developed, innovative food, food produced using new technologies and production processes, as well as food which is or has been traditionally eaten outside of the EU.

What is the current Novel Food legislation? As of 1 January 2018, the new Regulation (EU) 2015/2283 on novel foods (the new Regulation) is applicable. It repeals and replaces Regulation (EC) No 258/97 and Regulation (EC) No 1852/2001 which were in force until 31 December 2017.
