The maintenance of a pool should be covered in the special terms of the tenancy agreement. Generally, the tenant is responsible for everyday maintenance such as clearing leaves from the pool and may be responsible for regular maintenance. This should be discussed before signing a tenancy agreement.

If the landlord expects the tenant to undertake specific pool maintenance tasks, these should be outlined in the tenancy agreement with specific instructions as to how these tasks should be carried out. The landlord should also supply necessary equipment to maintain the pool such as pumps, vacuums, chlorinators and scoops.
